

## **ONLINE BROWSER** ENROLLMENT INSTRUCTIONS

For all new and existing users of online and mobile banking, you will need to enroll the first time you visit. Once you enroll, whether you enroll via an online browser or the mobile app, you will be able to log into either one with the credentials you set at enrollment. Begin by clicking the "Login" button found in the top right corner of the website.

## **ONLINE BROWSER** ENROLLMENT INSTRUCTIONS

After setting your security questions, you will be prompted to update your credentials. You must choose a Login ID that is not your Member ID.

Your **"Password"** will be the temporary password that was emailed to you, and that you used to login.

Your new password must be 8-15 characters long and contain upper and lower case, at least one number, and a special character.

Once you have completed this step, you have completed your enrollment and will be taken to your online banking.
