These emails or texts will claim to be from legitimate organizations with information about the coronavirus, requesting that you click on links or attachments for details. Some scammers are stating that they are giving away free money or products in an attempt to trick those who are out of work or in quarantine.

We encourage you to always identify the sender of an email. Avoid any emails that encourage you to "act now". Don't click on any links, and never respond to a message directly.

Another scam going around involves individuals or companies attempting to sell products that "cure" the COVID-19 virus. At this time, there is no known cure.
