TIPS ON WRITING "DONATIONS IN LIEU OF FLOWERS" CHECKS

When an obituary requests, "donations in lieu of flowers," those who are planning the service are either requesting financial assistance in paying for funeral services, or that a monetary gift be given to a charity in honor of the deceased. When giving money to help cover the cost of the funeral, it's most helpful to send a check made payable to either to the funeral home or the deceased's family; not to the name of the deceased. If you are sending a donation, many organizations are set up to receive them online, or you can send the donation by mail with a check, payable to the organization. When you donate to a nonprofit, be sure to mention the name of the person in whose memory you are sending the donation in the memo.
